Description Calculates phenological cycle and anomalies using a non-parametric approach applied to time series of vegetation indices derived from remote sensing data or field measurements. The package implements basic and high-level functions for manipulating vector data (numerical series) and raster data (satellite derived products). Processing of very large raster files is supported. Description

Based on the annual reference frequency distribution (rfd) of a vegetation index time series (e.g. a numeric vector of NDVI), calculates anomalies and how extreme these anomalies are (rfd position ranging from 0 to 100)

x	Numeric vector. A time series of a vegetation index (e.g. LAI, NDVI, EVI) or any other variable with seasonal behavior. The code has been optimized to work with integer values. Please re-scale the input values if necessary (e.g. NDVI ranging from 0.0000 to 1.0000, multiply by 10,000).
dates	A date vector. The number of dates must be equal to the number of "x" values (numeric input vector).
h	Numeric. Indicates the geographic hemisphere. This argument defines the starting date of the growing season. h = 1 for the Northern Hemisphere (season starting on January 1st), h = 2 for the Southern Hemisphere (season starting on July 1st).
refp	Numeric vector with the correlative number of dates to be used as reference period. For example, refp = c(1:388) for MODIS Vegetation Index 16-days composites MOD13Q1 (18/02/2000 – 18/12/2016)
anop	Numeric vector with the correlative number of dates for the period in which the anomalies and rfd position (how extreme the anomalies are) will be calculated. For example anop = c(389:411) for the complete 2017 of MODIS Vegetation Index 16-days composites MOD13Q1 (01/01/2017 – 19/12/2017). anop & refp can be overlapped.

rge	Numeric vector with two values setting the minimum and maximum values of the response variable (e.g. NDVI) used in the analysis. We suggest the use of theoretically based limits. For example in the case of MODIS NDVI or EVI, it ranges from 0 to 10,000, so <code>rge = c(0,10000)</code>
output	Character string. Defines the output values. 'both' (default) returns both anomalies and rfd position together as a single numeric vector, 'anomalies' returns only anomalies, 'rfd' returns only rfd values (how extreme the anomalies are) and 'clean' returns only extreme anomalies, i.e. anomalies at which a given rfd is overpass (e.g. 0.90). This critical threshold is set by the users using the rfd argument.
rfd	Numeric. This argument only applies when the argument output = 'clean'. It defines the percentile (from 0 to 0.99) of the reference frequency distribution, for which anomalies are not flagged as extreme anomalies. For example, if 'rfd = 0.90' only anomalies falling outside the '0.90 rfd' (default value) will be flagged as extreme anomalies while the rest will be neglected (NA values). Please notice that 'rfd = 0.90' implies that the 5% of the most extreme positive and 5% of the most extreme negative anomalies will be considered.

Details

Calculates anomalies and a probabilistic measure of how extreme the anomalies are using a numeric vector of vegetation canopy greenness, e.g. satellite based Normalized Difference Vegetation Index (NDVI) or Enhanced Vegetation Index (EVI). For this purpose, it divides the time series (numeric vector) of vegetation greenness into 2: the reference period, from which the annual phenological reference is calculated (same as [Phen](#) function), and the observation period, for which we want to calculate anomalies. This anomalies can be filtered by the position of the observation within the historical rfd. Users can, for example, set 'rfd = 0.95' to consider only anomalies that outside the 95% rfd of historical records.

rge	Numeric vector with the minimum and maximum values of the vegetation index used in the analysis. We suggest the use of theoretically based limits. For example in the case of MODIS NDVI or EVI, it ranges from 0 to 10,000, so rge = c(0,10000).
output	Character string. Defines the outputs. output = 'both' (default) returns both the vegetation index anomalies and rfd position together as a single numeric vector, output = 'anomalies' returns only anomalies, output = 'rfd' returns only rfd values (how extreme the anomalies are) and output = 'clean' returns only anomalies at which a given rfd is overpass (e.g. 0.90). This critical threshold is set by the users using the rfd argument.

rfd	Numeric. This argument only applies when the argument output = 'clean'. It defines the percentile (from 0 to 0.99) of the reference frequency distribution, for which anomalies are not flagged as extreme anomalies. For example, if 'rfd = 0.90' only anomalies falling outside the '0.90 rfd' (default value) will be flagged as extreme anomalies while the rest will be neglected (NA values). Please notice that 'rfd = 0.90' implies that the 5% of the most extreme positive and 5% of the most extreme negative anomalies will be considered.
nCluster	Numeric. Number of CPU cores to be used for computational calculations
outname	Character vector with the output directory path and filename with extension or only the filename and extension if the working directory was set. For example outname = "output_anom.tif". See writeRaster
datatype	Character. Output data type. For example datatype = "INT2S" for signed integer values. See writeRaster

Details

Similar to [ExtremeAnom](#), it calculates phenological anomalies but using a `SpatRaster` instead of a numeric vector of vegetation canopy greenness values (e.g. Leaf Area Index, LAI) or satellite based greenness proxies such as the Normalized Difference Vegetation Index (NDVI) or Enhanced Vegetation Index (EVI). For this purpose, it divides the time series (`SpatRaster`) of vegetation greenness into 2: the reference period, from which the annual phenological cycle is calculated (same as [PhenMap](#) function), and the observation period, for which we want to calculate anomalies with respect to the annual phenological cycle. Negative anomalies correspond to observed values lower than the reference and positive anomalies to values higher than the reference. These anomalies can be filtered by the position of the observation within the historical rfd. Users can, for example, set 'rfd = 0.95' to consider only anomalies that outside the 95% rfd of historical records.

Description

The functions in this package estimate the expected annual phenological cycle from time series or SpatRaster of vegetation (greenness) indexes. The algorithm to estimate the annual phenological cycle (used by the functions in npphen) uses a bivariate kernel density estimator in the index-time space. In this space, the x-axis corresponds to days of the growing season (1-365) and the y-axis to the vegetation index values, which range's values are set using the rge argument (see each function's vignette for details). The expected value of the index for each day of the growing season (the expected phenology) is approximated by the maximum value of the kernel at that day. Anomalies are calculated as deviations from the expected values at given days. The package implements basic and high-level functions for manipulating vector data (numerical series) and raster data (satellite derived products). Processing of very large raster files is supported. For methodological details of kernel density estimation see Wand & Jones (1994).

Derives the annual phenological cycle for a standard growing season using a numeric vector of vegetation canopy greenness values (e.g. Leaf Area Index, LAI) or satellite based greenness proxies such as the Normalized Difference Vegetation Index (NDVI) or Enhanced Vegetation Index (EVI). A vector with dates for the greenness values is also required.

A numeric vector, where each value represents the expected greenness at that date

Details

It is a "heatmap" of the annual phenological variability of the [Phen](#) output. It calculates and plot a likelihood map of the vegetation-index–time space using a numeric vector of greenness proxies such as the Normalized Difference Vegetation Index (NDVI) or Enhanced Vegetation Index (EVI). Also a vector with dates for the vegetation index values is required. This function is partially based on the `ci2d` function on package [gplots](#).

Details

Per pixel, it derives the most recurrent annual Land Surface Phenology (LSP) for a reference period using time series of satellite based greenness values such as the Normalized Difference Vegetation Index (NDVI) or Enhanced Vegetation Index (EVI). The annual LSP is calculated for all pixels of the input SpatRaster in the same way as for the [Phen](#) function. The output is a multiband raster where every band is the expected greenness value at a given time step of the growing season. For example, for MODIS Vegetation Index 16-days composites the number of time steps of the growing season is 23 (frequency = "16-days"), and therefore, the output raster will have 23 bands. A vector with dates for the greenness values is also required
